## Human Trafficking Two DAY FREE TRAINING December 17 & 18, 2019

Upon successful completion of the course, students will be able to:

- Understand the immigration process and how it is being fraudulently abused.
- Identify possible fronts located in their prospective areas of operation.
- Utilize interviewing techniques and questions needed to identify, investigate, infiltrate and convict these organizations.
- Conduct Multi-Jurisdictional Human Trafficking Investigations.
- Identify red flag indicators of Human Trafficking during the immigration process.
- Properly interview victims, witnesses, and suspects of Human Trafficking Organizations.
- Proactively follow various Social Media and internet websites commonly used by Human Trafficking Organizations.
- Identify common crimes associated with Human Trafficking Organizations to include money laundering techniques.
- Recognize Transnational Criminal Organizations and Mexican Drug Cartels involved in Human Trafficking.
- Covertly infiltrate Human Trafficking Organizations and conduct advanced undercover operations. Techniques to protect identity during ongoing investigations will be presented as well as several case studies.
- Identify common business fronts involved in Human Trafficking to include night clubs, bath houses, massage parlors, wellness centers, body language centers and several other types of businesses.
- Recognize difficulties and challenges during the prosecution phase of the investigations. Several case studies will be presented.
- Prepare themselves, as well as all victims and witnesses for courtroom procedures
